### BRAZIL'S CONSTITUTION AND CRIMINAL CODE PROTECTS MAFIA BOSS PASQUALE SCOTTI FROM LIFE SENTENCE IN ITALY!

The Brazilian Constitution **DOES NOT ALLOW LIFE IMPRISONMENT** and a person being extradited from Brazil is protected by the constitutional guarantee **ARTICLE 5, Clause XLVII(b)** (no life sentence) and the Brazilian Criminal Code, **ARTICLE 75**, which limits the maximum prison sentence to thirty (30) years. The determination of extradition is based in accordance with the domestic law of Brazil - not Italy.

**Pasquale Scotti**, 56 years old, was arrested by Brazilian Federal Police on May 26, 2015 within the northeastern Brazilian city of Recife, due to his convictions of murdering 26 people. In January 2005, he received a **LIFE SENTENCE IN ABSENTIA** from Italy.

Mr. Scotti was arrested in Italy in 1983 after a shootout with police and escaped through a window in his hospital room in 1984. He arrived in Brazil in 1986 using false identification documents, according to Brazilian and Italian Police during a news conference in Brasilia, Brazil on May 26, 2015.

Scotti was married to a local woman for 18 years and has two children. As a businessman in Brazil, he had a real-estate brokerage, fireworks factory, food import business and partly owned a nightclub. Giovanni Santoro, the communications officer of the Pernambuco federal police force, stated "He told us in a statement that his family was not aware of anything." His wife and family members claim they did not know he was a former Italian mafia leader of the New Camorra criminal organization and close ally of Raffaele Cutolo, head of the New Camorra group that participated in, and eventually lost, a bloody mafia war with members of the New Family crime group that led to almost 1,000 homicides from 1979 to 1984.
